*Application Number NP5/62/399A and NP5/62/399B which is the release of conditions on planning permission 12.11.2018 relating to the new Llanbedr road plans.

399A -Releasing condition 4 which is environmental A Construction: (regarding dust during construction: releasing condition 6 (regarding bats -register of commitments: and 7 (biosecurity risk assessment), dealing with things like japanesse knotweed, himalayan balsam when dealing with the landscape.

399B – Again releasing conditions as follows – condition 8 system (assessment: vibration , noise etc.; discharge condition 9 (dust control system); and condition 10 (water features survey)

All this to the land west of the Village.

However, Peter Simpson Street Services Manager (peterjohnsimpson@gwynedd.llyw.cymru) at the Council knows a lot about CCTV and it might be useful for you to have a chat with him. He understands the legal side and legal restrictions, what kind of provision is available and levels of services and monitoring available with CCTV. Also, he might know if there are grants available to fund what you hope to get to Llanbedr.
